# Information on the admission to ESMOD Seoul for foreign applicants

(Intake in March - school year of 2024/25)

General information on the course of fashion design and pattern drafting, on the application and on the visa procedure

#### Q: What is the course offered at ESMOD Seoul?

ESMOD Seoul offers a 3-year program specialized in fashion design and pattern drafting. A course specialized in fashion business isn't available at ESMOD Seoul. For more information on the course at ESMOD Seoul, refer to the link: <a href="ESMOD Seoul course">ESMOD Seoul course</a>

Q: Does the course of ESMOD Seoul offer a bachelor's degree after 3 years of study?

No, as ESMOD Seoul isn't recognized as a university, the graduates get the diploma of ESMOD Seoul.

#### Q: Is it possible for foreign students to join summer classes?

A summer class is a short course open for 2 weeks from the mid-July. The lectures are given in Korean and ESMOD Seoul can't sponsor the visa for a short course. Foreigners speaking fluently Korean and staying legally in Korea with their own visa can join this class.

#### Q: When does the school year of ESMOD Seoul start and end?

According to Korean national academic system, the school year of ESMOD Seoul <u>starts on the 2<sup>nd</sup> of March and ends around the 20<sup>th</sup> of February in the following year.</u> March intake is the only one a year.

#### Q: Do I need to know how to draw and sew before joining ESMOD Seoul?

No, it is possible to start as a beginner our 3-year "Fashion Design and Pattern Drafting" course. A strong motivation for the study of fashion design is the most important value.

#### Q: How many hours per week the students study at class?

Students study 6 hours a day, from 9:30 am 12:30 and 1:30 pm to 4:30 pm (30 hours per week). A lunch break is from 12:30 to 1:30 pm.

#### Q: When is the school vacation at ESMOD Seoul?

The school is closed during the school vacations in summer and in winter (5 weeks from mid-July to mid-August and 5 weeks from late December to late January).

### Q: After 1 or 2 years of study at ESMOD Seoul, can I transfer to ESMOD Paris or other schools of ESMOD to continue to study?

Yes. You can join directly the superior class of other ESMOD schools without repeating the same year.

#### Q: Are all classes in practical training at ESMOD Seoul?

The course of fashion design and pattern drafting mostly consists of learning skills and of having practical training. However, some of classes are theoretical and their lectures are given only in Korean (for example, Western costume history, fashion marketing). Only for these classes, according to the Korean language level, it might be possible for foreign students to submit reports and assignments instead of attending classes.

#### Q: Is there an international class providing all lectures in English?

No. An international class isn't available at ESMOD Seoul.

#### Q: Which language is required to attend the classes?

The foreign students have to speak fluently <u>one of two languages (English or French)</u> to communicate with the professors at ESMOD Seoul.

The lectures of the course are given in Korean as most of the enrolled students are Korean. The foreign students being able to communicate in English or in French are placed in a class with English-speaking or French-speaking professors. The foreign students need to understand approximately the lectures given in Korean. In case of difficulties in understanding, they will be helped by the professors.

#### Q: Do I need to prove my Korean language with a certificate of score of proficiency?

Yes. For the formalities of visa, it's mandatory to provide a <u>valid certificate of TOPIK I grade 1</u> (grade 1 is the lowest level of 6 levels). <u>(see below for more information on TOPIK tests and certificates)</u>

#### Q: The level TOPIK I grade 1, is it enough to understand the lectures?

No. Even though a sophisticated level in Korean language isn't required to attend classes at ESMOD Seoul, the foreign students are strongly recommended to reach, at least, a level of Korean proficiency equivalent to TOPIK I grade 2 (advanced than TOPIK I grade 1) to understand the lectures, to communicate with the classmates and to adapt easily to school life and living in Seoul. This grade 2 in Korean language doesn't have to be proven by a certificate of score of proficiency in Korean. This level will be tested during the admission interview.

Q: Do I have to prove my English or French language with a certificate of score of proficiency?

No. A certificate of score of proficiency in English or in French (TOEIC, TOFLE, DELF, DALF, etc..) is not mandatorily required. During the admission interview, the language level will be tested.

#### Q: When is the application to ESMOD Seoul closed?

The international application of the foreign students is closed by the 30<sup>th</sup> of October each year for March intake considering the preparation necessary for visa. It's preferable to apply earlier.

#### Q: I don't have any educational background in art. How do I prepare a portfolio?

A portfolio can be in free format with the applicant's own drawing or illustration, magazine clippings on fashion and art, etc... In case of no background in art, the portfolio can be made with magazine clippings in art or/and in fashion to show the applicants' interests.

#### Q: I'm foreigner currently living in Korea. Can I visit to ESMOD Seoul?

You contact the international admission service by email to book a visit to ESMOD Seoul. It's preferably recommended to attend the Open Campus in June. (see below for more info on the Open Campuses)

# Q: Can I submit the documents for application except a certificate of TOPIK I grade 1 or a certificate of completion of the basic course at a King Sejong Institute in my country by promising you to submit one of these certificates by due time?

Yes. ESMOD Seoul accepts your application without a certificate of TOPIK I grade 1 or a certificate of completion of the basic course at a King Sejong Institute in your country. But you have to provide a valid one by November 30<sup>th</sup> at the latest. If not, the admission might be cancelled due to the lack of time necessary for visa procedure.

#### Q: What is the school calendar of ESMOD Seoul for the school year of 2024-2025?

Entrance Ceremony & February 29<sup>th</sup>, 2024. All new students are asked to be present.

Orientation session

Class starting day March 4<sup>th</sup>, 2024

Semester 1 From early March to mid-July

Summer vacations from mid-July to mid-August (5 weeks)

Semester 2 From mid-August to mid-February of the following year

Winter vacations from late December to late January of the following year (5 weeks)

#### How to apply to ESMOD Seoul

As of the closing date for visa application scheduled on the end of November each year, the foreign applicants have to be <u>aged 18 years old or above and under 30 years old</u> with a diploma of <u>graduation</u> of high school or equivalency.

The requirements to apply to ESMOD Seoul are mostly related to the requirements to apply for visa D-4-6 (General trainee – Private institute) with which the foreign students are allowed to study at ESMOD Seoul (see below for more information on Visa to study at ESMOD Seoul).

#### Step 1: Prepare the documents below and send to the international admission service by email:

- 1. Application form attached to this document to fill out
- 2. Receipt of payment of application evaluation fee (the invoice is attached to this document).(\*) (\*) All applicants are asked to pay the application evaluation fee to apply to ESMOD Seoul. It's not refundable in any case.
- 3. Curriculum Vitae and Motivation letter written in English
- 4. Portfolio in free format showing your skills or interest in art and in fashion design
- 5. Photocopy of passport. Check the validity of the passport (the passport should have more than 6 months of validity in February of the school year, which means in February 2024)
- 6. Photocopy of certificate of graduation of high school
- 7. Photocopy of certificate of TOPIK I grade 1 or of certificate of completion of basic course of a Korean language course validated by King Sejong Foundation
- 8. If you're staying in Korea for language course or other reasons, Photocopy of resident card (face and back)

Note: The international application of the foreign students is closed by the 30<sup>th</sup> of October each year for March intake considering the preparation necessary for visa. It's preferable to apply earlier.

#### Step 2: Review of the application file and admission interview

Once received the application and the support documents, the applicants will be contacted by the international admission service to organize a zoom interview. The interview is mainly to understand your motivation to study the fashion design in Korea, your educational and cultural background, and also to evaluate your language level in English and in Korean. You'll know the result (accepted or not) in one week after the interview and receive by email the information on the registration to the school, the payment of the tuitions and visa procedure.

#### Visa to study at ESMOD Seoul

#### Q: Do I need a visa to study at ESMOD Seoul?

Yes. Foreign students admitted by ESMOD Seoul have to get the visa type <u>D-4-6 (General Trainee – Private institute)</u>. This visa type is valid for 6 months and renewable. As an inviting party, ESMOD Seoul is in charge of the procedure called "Confirmation of visa issuance" for D-4-6 with the immigration office. The foreign students have to provide all papers by due time as requested by ESMOD Seoul.

## Q: I've completed an advanced level at a Korean language institute in a university in Korea but I haven't take the TOPIK test. Do I have to provide a certificate of TOPIK I grade 1?

Yes. Even if your Korean language level is advanced enough, you have to fulfill the requirements for visa by submitting a valid certificate. Please sign it up in a hurry to take the test as soon as possible.

#### Q: Is it possible to work to earn money while studying at ESMOD Seoul?

No. Korean immigration law strictly prohibits the bearers of visa D-4-6 from working, even in part time. In case of violation of the law, you have to pay an important amount of fine and your application for renewal of visa might be rejected.

#### Q: What kind of documents do I provide to apply for visa D-4-6?

- 1. Certificate of graduation of high school,
- 2. In case of enrollment in a higher educational institute after high school, along with the certificate of high school, certificate of enrollment or graduation of a university,
- 3. Birth certificate,
- 4. Bank statement proving a balance of 5,000 USD or equivalent in the currency of your country in a bank account of your name

#### Note:

- √ The documents listed above should be certified Apostille in your country or, legalized by Korean Consulate in your country.
- $\checkmark$  The documents listed above should be in English. If it's not in English, a free translation in English should be attached to the document. A translation by sworn translator isn't necessarily required but it's preferable.
- $\checkmark$  The documents listed above should be in original copy and sent to the international admission service by express courier (DHL, Fedex, EMS, etc..) no later than the 30<sup>th</sup> of November.
- √ The bank statement is valid only for 30 days from the date of issuance until the date of application for visa. Be aware of the issuance date from the bank.

- 5. Photocopy of the certificate TOPIK I grade 1 or the certificate of completion of basic course at a King Sejong Institute (this document can be sent by email to ESMOD Seoul.)
- 6. 2 copies of passport sized ID picture (to be sent by express courier with the documents)

Attention : According to the nationality of the applicants, other documents might be added.

#### Q: After providing all papers for visa to ESMOD Seoul, what is the next step?

Your papers will be submitted by ESMOD Seoul to the Immigration office along with the documents related to ESMOD Seoul. After reviewing the application for visa, the immigration office lets know ESMOD Seoul if a confirmation of visa issuance is granted or not for you. When it's granted, you'll be contacted by ESMOD Seoul and you can start the procedure for the entry visa with the "Confirmation of visa issuance". For the entry visa, you should contact Korean Embassy in your country. ESMOD Seoul is expecting your arrival to Seoul during the 2<sup>nd</sup> or the 3<sup>rd</sup> week of February.

#### **TOPIK**, certificate of score of proficiency in Korean

4 or 5 tests of TOPIK a year are held in Korea. 1 or 2 tests are held abroad. #### **Korean language Institute recognized by King Sejong Foundation**

By the immigration law regarding visa type D-4-6, a certificate of completion of basic course can be accepted instead of a certificate of TOPIK I grade 1, if the course was taken at a King Sejong Institute of Korean language. A King Sejong Institute is a Korean language institute established outside Korea by the recognition of King Sejong Foundation.

#### **Open Campus**

The participation to one of 5 sessions of Open Campus is <u>a mandatory condition</u> for all applicants except the applicants staying abroad. Foreign students staying in Korea are recommended to attend the Open Campus, preferably in June. Each session having the same contents, no need to participate to every session. The Open Campus is held on site at ESMOD Seoul. Reserve your place at Open Campus prior to each session: seoul@esmod.co.kr

#### Q: I want to attend Open Campus to know the course without willing to apply in near future.

The Open campus sessions are open to all general public interested in ESMOD Seoul. The presentation is in Korean but our English-speaking staffs assist the foreigners in case of difficulties of understanding.

#### Q: What is the program of the Open Campus?

1 hour of presentation session about : presentation of the course and curriculum of ESMOD Seoul, testimonials of enrolled students and graduates, presentation of students' works in presence of professors. After the presentation, the participants can visit the school freely or have an individual meeting with professors.
